NAPEG is entering the third year of its current Strategic Plan. The first pillar of that plan was related to Act Revision.

We will be discussing revision with both Government of the Northwest Territories and Government of Nunavut over the next year. The first consultation with NAPEG registrants happened at the NAPEG Planning Session on November 30 in Yellowknife. The Act and Bylaw Revision Committee met to recommend revisions and NAPEG Council, at a meeting on December 12, agreed in principle with the proposals from the committee.

We will be continuing with consultation over the next few months. There will be an opportunity to ask questions, provide input and discuss the proposals at the Annual General Meeting on March 11, 2020 and at the Annual Professional Development Symposium being held on March 12 and 13 at The Explorer Hotel in Yellowknife.

The Objectives of the 2017 - 2020 Strategic Plan are:

1. Review and propose revisions to the Engineering and Geoscience Professions Act;

2. Improve Communications and Outreach with Governments, the Public, and Members;

3. Position NAPEG for Long-term Success and Sustainability;

4. Focus on Continuing Professional Development;

5. Grow Volunteer Base and Strengthen Volunteer Relationships.

In addition to meetings related to Act Revision, other areas requiring some work in 2020 are related to risk management to ensure long-term success and sustainability of NAPEG.

2020 will be a busy year and a year of change. Early in the year, elections will bring about some new faces on Council. We are hoping to increase staff at the NAPEG Office by one more person to assist in regulatory work.

As 2019 comes to a close, I want to express my appreciation to members of NAPEG Council, Support Staff and to you, the registrants.

May 2020 be a celebration of good health, productivity and great achievement.

Congratulations to all Members of the Legislative Assembly on your election in the Fall.

In particular, congratulations to NAPEG Past Member of Council, Katrina Nokleby, P.Eng., who was successful in her riding, and also became a Member of Cabinet.

While we will miss you on Council, Honourable Minister Nokleby, we recognize this major life achievement, and your dedication and service toward improving equality and prosperity of all Northerners.

## Celebrate the Future - Remember the Past

In 1969, a group of engineers and geologists formed the Society of Professional Engineers of the Northwest Territories. This eventually led to the acclaiming of legislation by the Territorial Legislature in 1979 establishing the Association of Professional Engineers, Geologists and Geophysicists of the Northwest Territories (NAPEGG).

On April 1, 1999, the new territory of Nunavut was created by Federal legislation entitled The Nunavut Act. On the same date, NAPEGG was granted the authority to regulate the professions of engineering, geology and geophysics in Nunavut.

On May 1, 2008, new Acts came into force in both the Northwest Territories and Nunavut. The new name of the Association became the Northwest Territories Association of Professional Engineers and Geoscientists. NAPEG administers both Acts and uses the business name: Northwest Territories and Nunavut Association of Professional Engineers and Geoscientists (NAPEG).

The first Annual General Meeting was held in 1980. In 2020, NAPEG will be celebrating Forty (40) Years since NAPEG, as a regulator, was established. Considering the vision of the early engineers, geologists, and geophysicists who recognized the importance of protecting the interests of the Northern public, we recognize Fifty (50) Years for those members of the Society and salute those visionaries from the past.

## Finnigan Award Recipients - NWT and Yukon



**Shelby Austin-Fafard, B.Sc. (Geology)**

**Masters of Geology Candidate, University of Saskatchewan**

Title: Volcanic Setting of the South Sunset Rhyolite, Beaulieu Volcanic Belt, Slave Province

This study focusses on Neoproterozoic volcanic rocks that are part of the Beaulieu volcanic belt, located ~100 km east northeast of Yellowknife. The Beaulieu volcanic belt host the Sunrise volcanogenic massive sulfide (VMS) deposit at the north-end of Sunset Lake. Shelby's research is centred on the South Sunset Rhyolite strata at the south end of Sunset Lake. The age and the stratigraphy of these rocks are unknown; therefore, they cannot be correlated to those that host the Sunrise deposit or to any volcanic rocks within the Beaulieu volcanic belt.

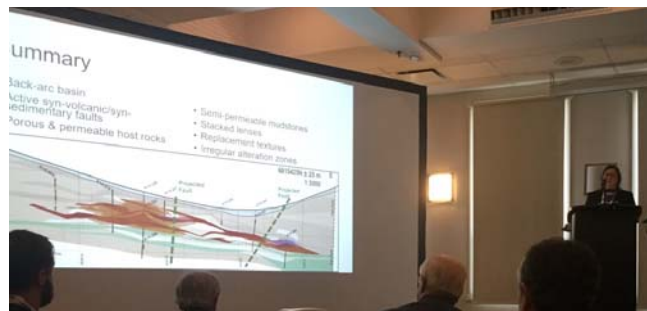

Title: "Lithostratigraphy, replacement style VMS mineralization and alteration at the Kudze Kayah deposit, Finlayson Lake District, Yukon.



*I am very grateful and honoured I was selected for the Finnigan Award, it allowed me to visit the Yukon Geoscience Forum. My thesis concerns an active late exploration-stage project in the Yukon Territory and this was the first time I presented on the results. I really appreciated that it was to an audience who knew the context of the project and was familiar with the geology of the area and was able to give me great feedback I would not be able to get anywhere else. It was also a great opportunity to meet the people actively working with geology in the Yukon Territory and learn about the new and ongoing projects.*

## About Craig Finnigan and the Award



Dr. Craig Finnigan (Professional Geoscientist) spent the majority of his short career working across the North for industry, government and academia. Craig passed away in 2014 at the age of 45. His passion for geoscientific field work and exploration left an imprint on those who worked with him over the years.

Craig thrived on opportunities in the North and added significantly to our understanding of the geology in a number of places including the metallogeny of gold in the Kivalliq District of Nunavut, Yellowknife Northwest Territories, and the Dawson Range, Yukon.

He completed his M.Sc. degree on the gold mineralization in the Yellowknife belt and was recognized by AMEBC in 2014 with the prestigious Huestis Award for his role in the discovery of the Coffee gold deposits in the Yukon.

Craig was an adamant supporter of students and education. As Adjunct Professor at Western University, he co-sponsored MSc theses on the Coffee gold deposits and another that studied uranium mineralization at the Lac Cinquante uranium deposit in Nunavut. A student focused scholarship that encourages presentations at northern conferences is a fitting and appropriate concept for Craig's memory.

Three awards (one in each Northern territory) are given annually to a student presenting at: Yellowknife Geoscience Forum, Yukon Geoscience Forum, and Nunavut Mining Symposium.

## NAPEG Non-Practicing Policy

### Section 25.a of NAPEG Bylaws:

Council may establish a non-practicing membership category for members and licensees who have ceased to practice professional engineering or professional geoscience in the Northwest Territories but who wish to remain affiliated with the Association. The annual fee for non-practicing members/ licensees shall be determined by Council from time to time. Non-practicing registrants shall show (Non-Practicing) after their designation to provide clarity for public interest.

### Section 22 (1) of the *Engineering and Geoscience Professions Act*:

Council may require a member or licensee who, for a period exceeding five years, has been inactive in the field of practice in which the member or licensee obtained his or her qualifications for registration within his or her designated profession, to have his or her present qualifications reviewed by the Board of Examiners.

### Policy:

A member or licensee may request, in writing, a change in status from *Active* to *Non-Practicing* to the Registrar. The request will be reviewed by the Membership and Enforcement Committee and their recommendation will be submitted to Council for final decision on approval.

A member or licensee is not allowed to practice their profession in the Northwest Territories and/or Nunavut when their status is non-practicing. To resume practice, the non-practicing member/licensee must submit a request, in writing, to the Registrar to change from non-practicing to active status. The request will be reviewed by the Membership and Enforcement Committee and their recommendation will be submitted to Council for final decision on approval. The Reinstatement Policy will apply to all applicants.

A member or licensee, who has non-practicing status with NAPEG, will submit the following declaration annually.

#### NON-PRACTICING DECLARATION

I declare that I am not engaged in the practice of professional engineering or professional geoscience in the Northwest Territories and/or Nunavut.

I agree not to engage in the practice of professional engineering or professional geoscience in the Northwest Territories and/or Nunavut until I have requested and been granted a change to active status.

Please check one of the following options:

I am actively practicing professional engineering or professional geoscience in another jurisdiction as below:

I am not practicing professional engineering or professional geoscience in any other jurisdictions.
