## **Change to Policy on Fees (within Annual Dues Policy)**

At the September Council meeting, a revision was made to the Annual Dues Policy that will allow staff to close files when application fees (pro-rated annual dues and stamp) remain unpaid after ninety days. The non-payment may mean the applicant did not get a project as hoped, had not completed their registration, and neglected to withdraw their application. At any given time, there can be a number of such files sitting in limbo while creating extra work in sending reminders each month. Closing the file won't prevent a practitioner from getting registered in the future. They simply need to reapply.

Here are the relevant sections to the policy:

- An applicant is not a registrant or permit holder until after the approval process, and payment of fees, is complete.
- If an applicant does not pay annual dues and/or stamp within 90 days of the tentative (pending payment of fees) approval date, the file will be closed and they will need to reapply, as required within the Acts and Bylaws.

If a <u>registrant</u> does not pay within 90 days, the process is a little different in that Council would direct the Executive Director to remove the practitioner from the register (striking). In this case, to be reinstated the registrant would need to pay additional fees. You can see the full policy on the NAPEG website.

### **Notification of Public Review - CSA S502**

CSA S502 draft on *Managing changing snow load risks for buildings in Canada's North* is available for Public Review.

The objective of this Standard is to inform communities on measures for safe roof snow removal from existing buildings and for protection of building occupants and assets from overloading risks due to increasing accumulations and weights. Procedures that can reduce risks for roof and building collapses are outlined, including procedures for monitoring heavy snow and ice accumulations, safe removal of snow on roofs when needed, and for maintenance and snow removal planning.

# **Consultation on Amendments to the Wastewater Systems Effluent Regulations**

Environment and Climate Change Canada (ECCC) is looking for your comments on proposed amendments to the *Wastewater Systems Effluent Regulations* with a focus on two specific areas:

**Transitional Authorizations:** ECCC is proposing to allow eligible communities another opportunity to receive an extension (transitional authorization) to comply with the Regulations. The rules for qualifying for this extension, and the deadline to upgrade or build a new wastewater treatment facility would remain the same.

**Expansion of existing temporary bypass authorization:** ECCC is also proposing to expand the existing temporary bypass authorizations in the Regulations to include planned releases of wastewater from sewer systems. This approach is being considered to improve transparency and result in the least possible impact on the environment. The amended regulations would allow eligible communities to apply for a temporary bypass authorization for short term releases.

In the public interest, NAPEG regulates and supports the professional practice of engineering and geoscience in the Northwest Territories and Nunavut.

## **NAPEG Digital Signature**

As of September 1, 2020, Digital Signatures have been available to NAPEG Professionals. Within the first ten days, there were 15 approvals. Check the website for details on how to apply.

#### What is a digital signature?

It is the affixing of a digital signature certificate that cryptographically secures an electronic file, thus proving the origin, the authenticity of the signer, and confirms the integrity of the signed document.

#### What is an electronic document?

An electronic document is a document carried by electronic, logical and visual media.

#### What is a digital signature certificate?

It is a computer artefact issued and cryptographically protected by a Certificate Authority (Notarius) attesting to the veracity of the information declared in the certificate. This information may include:

- Full name;
- Email address;
- Professional title;
- Membership number;
- Public key;
- Validity period and the serial number of their certificate.
