9. Financial Statements

Justin Hazenberg, P.Eng., led members through the Audited Statement prepared by Avery Cooper and Co. Ltd., beginning on Page 27 of the 2020 Annual Report. Executive reviewed the Financial Statements in detail. He noted a surplus of \$130,000 and revenues increased by \$30,000. Expenses were under budget approximately \$100,000 partly from wages and benefits. Staffing will be reviewed in the coming year and a continuity plan developed. \$60,000 was spent to promote science and technology in the North through the Aurora College CubeSat project. The Discipline Reserve is \$250,000 and the Operations Reserve is \$243,000. The reserves policy is reviewed annually.

NAPEG Council approved the Audited Financial Statements to December 31, 2019 at the March 6, 2020 meeting of Council.

PRESIDENT'S REPORT Justin Hazenberg, P.Eng.



2020 started out with a lot of positives for the Association. NAPEG was wrapping up a three-year strategic plan. Our finances were solid, and the Association was positioning itself well to take on new challenges.

One major emerging challenge for the regulator was how self-regulation is under scrutiny across Canada. NAPEG began the process to review its operations in detail and whether all operations were appropriate for a regulator. These discussions on NAPEG's future would form the basis of the next strategic plan.

Some NAPEG policies were updated in the early part of 2020. The policies were relating to appointment of Engineers Canada and Geoscientists Canada Directors and Public Members to Council. The selection process was formalized through the Nominating Committee. Appointees are selected for a three-year term, with a normal cap of two consecutive terms.

Exceptions to the term cap can be made in special circumstances, such as a Director running for President of Engineers Canada or Geoscientists Canada. This term cap for our Directors and Public Members on Council will provide more opportunities for individuals and fresh ideas to come to the table. Additionally, terms of Committee Chairs and contributions of members of Council on Committees has been reviewed. This work is ongoing and will continue in 2021.

The world changed before our eyes during the 2020 NAPEG Professional Development Symposium. The rapid spread of the SARS-CoV-2 virus resulted in public health agencies across the world issuing various restrictions. Many offices, including NAPEG, moved to a work from home model. NAPEG staff handled this situation well with minimal impact on normal operations. Effective regulation of the profession was maintained, and we continued to add new members.

NAPEG Council and committees moved to online meetings. This had its challenges, but also had some benefits. Engagement of members from outside of Yellowknife greatly improved with online platforms versus the former teleconference system. All participants were on an equal footing, were able to visualize who was speaking, and meeting materials were more effectively shared. As public health orders ease in the coming year, we will shift to a hybrid model of online and in-person meetings enabling maximum engagement.

NAPEG Council has passed a resolution to begin the process of transferring some responsibilities to the NAPEG Education Foundation (EF), such as Outreach and Awards. This is to address some of the concerns surrounding duties of a regulator to ensure we maintain the right to self-regulate.

The Education Foundation Committee has a new Chair, Melanie Williams, and will review the recommendations and report back to Council/EF Board. This process is expected to take until the 2022 AGM.

A technological milestone was reached in 2020 with the adoption of an agreement to provide secured, digital stamps. Members have been creating digital copies of their stamps for many years; however, until recently there was no approved methodology to encrypt and verify these stamps. Therefore, NAPEG partnered with Notarious to implement a system of digital sealing of documents.

The new system provides significant enhanced protection for both members and the public. Customers and others reviewing documents will know with certainty that they are viewing original, unaltered documents sealed by members in-good-standing with the Association.

PAST EXECUTIVE DIRECTOR'S REPORT

Linda Golding, FEC/FGC (Hon.)



This is my last Annual Report as your Executive Director/Registrar. Your new Executive Director/Registrar was appointed effective February 1, 2021. We welcome Vince McCormick to the position.

I actually said most of what I would have said in a final report last year. Initially, I had expected to be retired about six months sooner than this. The delay worked out okay for both me and for NAPEG. I do enjoy the job and the people. I also look forward to retirement.

It has been an amazing 20 plus years working with so many dedicated professionals and staff. I do wish that the Act Revision had happened while I was still here, but from past experience those changes do not get accomplished quickly.

This past year, since the last AGM and events, has been like no other in our history. We had barely completed the NAPEG events when the territories shut down due to the COVID-19 Pandemic. The first few months we were afraid to go anywhere, do anything without a lot of sanitizing, face cover and distancing. While we still maintain these precautions to a degree, we did reopen the office in early August 2020. Not everyone returned to the office and those who did return still sometimes work remotely depending on health and family circumstances.

Almost all staff have experienced times of isolating for 14 days due to personal travel, medical travel, or COVID testing (a precaution in case a cold or coughing from asthma was more than just a cold or asthma). Our world has changed and may not go back to what we thought of as 'normal'.

For NAPEG Committees, volunteers and staff, meetings are now all virtual, although we did have a Council meeting at The Explorer Hotel in December that was a combination of in-person and WebEx. We have none of the normal social networking, professional development events, or boardroom meetings as in the past. We are learning to adapt to these changes.

It was very odd to not be planning for the Annual Model Bridge Building Competition and Coding event in conjunction with Engineering and Geoscience Week. We also could not have a Networking Social so that Members-in-Training and New Professionals could chat with more seasoned Professionals. We used to have an annual Rings-and-Wings event for both networking and to encourage donations to the Education Foundation. On that note, you can still submit donations to the Education Foundation and receive a tax-deductible receipt as the Foundation is a registered charity.

The regular two-days of Professional Development turned into five days of shorter presentations so that members still have access to Continuing Professional Development (CPD) Hours. For some registrants, the pandemic has allowed them the time to fill up those CPD hours with free on-line learning plus more time to read technical reports and periodicals.

Award presentations will be delayed (hopefully in June) but it hasn't stopped the Honours and Awards Committee from receiving and considering nominations. By the time you are reading this there will have been Council approval of the awards for 2021. There are so many great projects and people deserving of recognition.

My congratulations and thanks to members of Council and volunteers for your friendship and all the support you have given me over the years. A huge thank you to support staff for all you do for me and for the organization. We are truly blessed with both staff and volunteers who continually walk the extra mile.

NAPEG will be working closely with regulators across Canada to inform government and the public about the importance of qualified, experienced and licensed Professional Engineers and Professional Geoscientists to public safety and the economic health of our territories and the country.

Regulation is, of course, our number one priority. In terms of promoting the professions, recruitment and retention of professional women (e.g. through the 30 by 30 initiative), outreach to students encouraging them to take math and science subjects and pursue geoscience and engineering degrees, and efforts at diversity and inclusion, especially in the area of Indigenous persons, will be a continued focus.

Hopefully the availability of vaccines and the hard work of public health and allied professionals will enable all of us to get back on a more normal footing and we will once again be able to meet in person! Until then, I am looking forward to meeting as many of you as possible virtually.

Engineers Canada Director's Report

Sudhir Jha, P.Eng., FEC



What can we say about 2020? It has been a year like no other in history because of COVID-19.

Within the context created by COVID-19, it is especially gratifying to offer my sincere thanks and appreciation to the Engineers Canada staff and Board members – and to the NAPEG staff and Council – for their unwavering dedication and commitment to our profession and the organization during very trying times.

To each of you, thank you for making our new virtual world workable and even enjoyable as we all met from many miles away. We accomplished a great deal in 2020 despite the challenges. Following are the highlights.

COVID-19

As COVID-19 spread in early 2020, Engineers Canada closed its offices and staff worked from home. All Engineers Canada meetings were held virtually. Regulators, via groups such as the CEO Group and officials groups, actively shared information on their experiences and best practices in dealing with the COVID-19 crisis, including how to virtually sustain operations, conduct government interactions, address admissions issues, conduct licensing and discipline hearing procedures, and offer outreach programs including National Engineering Month.

Engineers Canada Board

Jean Boudreau was inducted as the 78th president of Engineers Canada and Danny Chui was named presidentelect at the spring Board meetings.

As directed in 2019, the Governance Committee presented a plan at the May 2020 Board meeting to reduce the size of the Board. The Board voted to keep the size of the Board as is.

Strategic planning process

Work began in 2019 to review and revise the Engineers Canada strategic plan. Several subsequent sessions were held throughout 2020, leading to a fall information session for regulators and other stakeholders on the proposed strategic priorities of the 2022-2024 strategic plan. Consultations were held with regulators in October and November. A revised draft of the strategic plan will be presented to the Engineers Canada Board at their February meeting, in preparation for consideration by regulators at the May 2021 Annual Meeting of Members.

National membership report

In November, the 2020 National Membership Report was released. This annual report gathers information on provincial and territorial engineering regulators' membership. This year's report indicates continued growth of the profession.

International Institutions and Degrees Database

Engineers Canada signed a contract in fall 2020 with EXNP to provide a new online tool to replace and improve the International Institutions and Degrees Database (IIDD). Development work has started, and the project is expected to be finished in the first quarter of 2021.

National Membership Database

Vendor selection for the new National Membership Database (NMDB) continued in 2020 with the procurement phase expected to be complete in Q1 2021. Work on the new tool, updated to enhance security, incorporate improvements requested by the National Admissions Officials Group, and to move to cloud infrastructure, is expected to begin in March.

Government relations

Engineers Canada continued advocating to the federal government, focusing on engineers' roles in Canada's post -pandemic recovery. Our August pre-budget submission to the federal government referenced several specific actions across Canada, all of which were referenced in the government's Speech from the Throne in September.

Engineering Accreditation Board (CEAB)

As a result of discussions between the CEAB and Engineering Deans Canada about the impact that the COVID-19 pandemic had on the delivery of education at higher education institutions. CEAB, the Engineers Canada Board voted in May to reduce the minimum accreditation units of program from 1,950 to 1,850, effective starting with the 2021/2022 accreditation visit cycle.

Canadian Engineering Qualifications Board (CEQB)

Over the past year, the CEQB approved the revised basic studies, biomedical, software, and computer engineering syllabi; the revised *Regulator Guideline for the engineer-in-training program*; the *Public guideline on risk management* (to be submitted to the Engineers Canada Board for final approval); and the terms of reference for the new task forces on diversity and inclusion and software engineering.

In closing, it is my sincere pleasure to offer heartfelt thanks and best wishes to Linda Golding. Even though Linda has retired from her duties as NAPEG Executive Director, she has done another tremendous job organizing tonight's AGM.

On a personal note, Linda, thank you for all the support you have so generously given me as a member of NAPEG, during my time on the Council and as President, and during my time with Engineers Canada. You answered my questions, made phone calls that helped me, found the right person for me to talk to, organized meetings and reports, and did so much more for me and for our organizations that I, fortunately, remain completely unaware of.

Enjoy your retirement. We will all miss you.

GEOSCIENTISTS CANADA DIRECTOR'S REPORT

It has been my privilege to have spent the last year as a Director representing NWT and Nunavut on the Board of Geoscientists Canada (GC), and additionally as the organization's treasurer. I would like to extend an invitation to all the geoscientists working in the NWT and Nunavut to please reach out to me with any questions or concerns you might have regarding the profession that you feel could benefit from access to a national platform.

Geoscientists Canada is a national organization, created by the provincial and territorial regulatory associations – Constituent Associations (CAs), working toward consensus and consistency on regulatory matters. Canadian regulation of the practice of geoscience is legislated at the provincial/territorial level; therefore, the role of regulator is the responsibility of the CAs, including NAPEG. Geoscientists Canada was formed to

provide support for joint activities, allowing the CAs to have a forum where they can develop consistent standards and best practices.

The following are some highlights of activities over the last 12 months:

- Geoscience Canada celebrates its 25th anniversary year in 2021. Over the past quarter century, dedicated board and committee members, supported by regulators, have successfully accomplished a wide variety of initiatives in support of the development of high national standards of admission, competency, practice and mobility to ensure that Canada is served by a skilled, versatile, reputable and accountable geoscience profession.
- Geoscience Canada welcomed a new incoming president, with Mr. Michael Parkhill taking over from Mr. Jeff Parks. Mike holds a Bachelor of Science – in Geology/Earth Science from the University of New Brunswick (1985). He is currently a Quaternary Geologist with the New Brunswick Department of Natural Resources and Energy Development, Geological Surveys Branch, and has over 35 years of geoscience experience dealing with drift mapping and sampling projects (EXTECH-II, MDA, CNB-CAMD, NATMAP, TGI) documenting Quaternary and bedrock geology in New Brunswick and has authored or co-authored over 225 papers, maps, reports, and conference abstracts.
- A new website *Geoscience in Canada* (www.geoscienceincanada.com) has been launched. This important resource is designed to inform internationally and domestically trained geoscientists about practicing geoscience and professional geoscience licensure requirements in Canada. This resource is available to all prospective professional geoscientist applicants, regardless of the jurisdiction to which they may eventually apply and is offered at no charge to users.
- Engagement continues with the United Nations Economic Commission for Europe (UNECE) United Nations Framework Classification for Resources (UNFC), an international scheme for the classification, management and reporting of energy, mineral, and raw material resources.
- Licensing agreements for the certification marks ("Professional Geoscientist" and "P.Geo") that were obtained last year have been drafted. Ongoing consultation with the CAs is required prior to any finalization and implementation.
- Work has begun to refresh the organization's website, to provide a more functional and modern interface.

During the 2020 GC AGM, the 2020 Canadian Professional Geoscientist Award was presented. Enforcement - Compliance Matters

NAPEG addresses concerns of individuals and firms practicing engineering and/or geoscience for projects in the Northwest Territories and/or Nunavut without being licensed to do so. In attempting to know who to address, there are many methods used to identify the individuals and/or firms. Members have a duty to report when they are aware that an engineer or geoscientist or firm is not licensed to practice in the North. NAPEG staff review information obtained through reporting avenues, such as reports to Water Boards or NI 43-101 reports, as well as information within newspapers, magazines, linked-in profiles and other forms of social media. Usually the response, once identified, is positive and results in the person or firm obtaining a license to practice.

Another area of practice that is checked for compliance is annual reporting of Continuing Professional Development Activities. NAPEG is just passing their first three-year cycle since reporting became mandatory. The process and number of audits will be refined and revised in the next few months. It is hoped that NAPEG request for Act Revision will result in clear sanctions for non-compliance.

Audits of Registrant Applications

Random audits are performed by members of the Membership and Enforcement Committee to ensure: that practitioners in the NWT and Nunavut have been examined and that their qualifications met the requirements; that applicant/registrant files are complete and contain all required documents; that all applicants (according to category) are treated consistently, i.e., held to the same standards; that requirements under the Acts, Bylaws and Policies are followed; that identify any issues or concerns, as they arise, and to recommend methods that may improve the process; that members of the Membership and Enforcement Committee are familiar with the processes involved in admission and registration of practitioners and firms. **Note: Audits below were delayed due to pandemic.**

Discipline Matters

At the present time, there are two active discipline investigations. Another case has been directed to a Board of Inquiry. The Discipline Committee may be able to resolve one case using Alternative Dispute Resolution (ADR) process. ADR requires that all parties agree to the process.

There is a request, as part of proposed revisions to the Acts, to have a member of the Public serve on the NAPEG Discipline Committee. Members of NAPEG Council cannot serve on the committee or have knowledge about complaints, as three Council members would serve as a Board of Inquiry if a case goes to a hearing.

NOTES TO THE NON-CONSOLIDATED FINANCIAL STATEMENTS December 31, 2020

1. NATURE OF OPERATIONS

Northwest Territories and Nunavut Association of Professional Engineers and Geoscientists (the "Association") ("NAPEG" or the "Association") was incorporated September 25, 1970 and is continued under the *Engineering and Geoscience Professions Act* (Northwest Territories) and the *Engineers and Geoscientists Act* (Nunavut) dated May 1, 2008. The objectives of the Association are:

- to regulate the practices of professional engineering and professional geoscience and to govern the professions in accordance with these Acts and bylaws.

- to establish and maintain standards of knowledge, skill, care and professional ethics among its members and licensees, in order that the interests of the public may be served and protected.

The Association is exempt from income taxes under paragraph 149(1)(l) of the *Income Tax Act* (Canada).

2. SIGNIFICANT ACCOUNTING POLICIES

These non-consolidated financial statements are prepared in accordance with Canadian accounting standards for not-for-profit organizations. The significant accounting policies are detailed as follows:

(a) Basis of presentation

The financial statements were presented in accordance with Canadian accounting standards for private enterprises (ASPE).

The Association has elected to report each controlled entity by providing the disclosure as set out in Note 14. Accordingly, these non-consolidated financial statements present the financial position, results of operations and cash flows of the Association and exclude the accounts of The NAPEGG Education Foundation (the "Foundation"). The financial position, results of operations and cash flows of the Foundation are presented in a separate set of financial statements that do not include the financial position, results of operations.

(b) Cash and cash equivalents

Cash and cash equivalents include cash and short-term investments with maturities of three months or less from their date of acquisition, which are readily convertible into a known amount of cash, and are subject to an insignificant risk to changes in their fair value.

(c) Short term investment

Short term investments are carried at cost plus accrued interest.

2. SIGNIFICANT ACCOUNTING POLICIES, continued

(d) Financial instruments

The Association initially measures its financial assets and liabilities at fair value, except for certain non-arm's length transactions. The Association subsequently measures all its financial assets and financial liabilities at amortized cost.

(e) Investments

Investments are carried at cost plus accrued interest.

(f) Tangible capital assets

Tangible capital assets are recorded at cost. The Association provides for amortization using the declining balance method at rates designed to amortize the cost of the tangible capital assets over their estimated useful lives. One half of the year's amortization is recorded in the year of acquisition. No amortization is recorded in the year of disposal. The annual amortization rates are as follows:

Computer equipment	30%

Furniture and fixtures	20%
Leasehold improvements	20%

(g) Website development costs

The Association expenses website development costs when incurred.

(h) Deferred revenue

Deferred revenue consists of subsequent year dues collected during the current year.

(i) Revenue recognition

Annual dues and registration fees are recognized as revenue in the year earned. Fees, other revenue, and investment interest are recognized when earned.

(j) Contributed materials and services

The Association and its members benefit from donated materials and services in the form of volunteer time for various committees. Contributed materials and services are not recorded.

(k) Measurement uncertainty

The preparation of non-consolidated financial statements in accordance with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the period. Significant areas requiring the use of estimates include: allowances for doubtful accounts and estimated useful lives of tangible capital assets. Actual results may differ from management's best estimates as additional information becomes available in the future.

10. COVID-19

Events have occurred as a result of the COVID-19 (coronavirus) pandemic that have caused economic uncertainty. The duration and impact of the COVID-19 pandemic, as well as the effectiveness of government responses, remain unclear at this time. Potential risks that the Association faces as a result of the pandemic are as follows:

- (i) Significant change in operational costs
 - Assessment and response:
 - Change in operational costs, if any, have been reflected in the financial statements.
- (ii) Due to reduced cash inflows and/or increased operating costs, the Association may be in an operating deficit position which may necessitate increased fees or a special assessment
 - Assessment and response:
 - The Association has positive working capital and is in an operating surplus position. The Association continues to be a going concern.
- (iii) Valuation issues related to capital assets
 - Assessment and response:

Impairment testing for capital assets has been done and there is no impairment based on the current market value of the capital assets.

11. DISCIPLINE & ENFORCEMENT RESERVE

Expenditures for discipline and enforcement matters, which exceed the budgeted amount in any given year, will be taken from the Discipline & Enforcement Reserve. The Reserve will then be reimbursed. Expenses reimbursed on such matters during the year totaled \$24,587 (2019 - \$7,587). Council will at times approve transfers to the Reserve. The Reserve at December 31, 2020 is \$225,413 (2019 - \$250,000).

12. OPERATIONS RESERVE

According to the Association's Act of incorporation, any unrestricted assets derived from carrying on the affairs and business of the Association shall be devoted and applied towards regulation and carrying on its objects and purpose, and shall not be divided among its members. According to Association policy, the unrestricted net asset balance should be maintained at a balance not less than 25% of previous year's revenues from annual dues and registration fees. At December 31, 2019, this reserve is \$249,827 (2019 - \$243,173).

The Association maintains sufficient investments to ensure coverage of the Discipline & Enforcement Reserve, and the Operations Reserve.

13. RELATED PARTY TRANSACTIONS

The Association controls through a common council The NAPEGG Education Foundation. The Foundation was incorporated August 28, 2000 under the *Societies Act* (Northwest Territories). The Foundation is a registered charity under paragraph 149(1)(f) and is exempt from income taxes under subsection 149.1(1) of the *Income Tax Act* (Canada). The purpose of the Foundation is to promote training and education in the fields of engineering and geoscience.

The balance due from related party at year end is a donation that was accepted by the Association on behalf of the Foundation in 2019, and is unsecured, non-interest bearing, and due on demand, with no specified repayment terms.

During the year the Association incurred donation expenses with the Foundation totaling \$100 (2019 - \$1,422). In addition, the Foundation receives administrative services and use of offices from the Association without charge.

These transactions are in the normal course of operations and have been valued in these nonconsolidated financial statements at the exchange amount, which is the amount of consideration established and agreed to by the related parties.
